OPERATION OF TWO BIRTH WAITING HOMES (TIKONKO & GONDAMA); 290 PREGNANT AND POST-PARTUM WOMEN STAYED AT THE TWO BIRTH WAITING HOMES THIS PAST FISCAL YEAR, GIVING THEM ACCESS TO SAFE CHILDBIRTH AND POSTPARTUM AREA, AND TRANSPORTATION TO THEIR HOME VILLAGES. THIS SUBSTANTIALLY REDUCED THE MATERNAL AND NEWBORN MORTALITY IN THE CHIEFDOM.
